



**PROPOSAL TO PROVIDE ATHLETIC TRAINING SERVICES
SAN LEANDRO HIGH SCHOOL 2015-16**

Sean Mosbey ATC, CSCS will provide Athletic Training services to San Leandro High School for all student athletes. Said services will begin on June 29th 2015 and end on June 11 2016. Services will be provided by Sean Mosbey ATC, CSCS.

The following provisions will be observed:

1. The Certified Athletic Trainer will examine and treat all injuries occurring to athletes and/or refer them to proper health care professional for further care. Provide injury prevention services, including the use of education, therapeutic exercise, supportive taping and other protective devices.
2. The Certified Athletic Trainer will assist coaches in the implementation of injury prevention techniques and the design of safe and effective exercise programs and rehabilitative programs for the injured athlete.
3. The Certified Athletic Trainer will maintain a training facility and distribute training supplies and equipment supplied by San Leandro High School. The Certified Athletic Trainer will organize and prepare first aid kits for the coaches.
4. Maintain records concerning all athletic injuries occurring and their treatment or disposition.
5. The Certified Athletic Trainer will promote good health habits in the student athletes.
6. The Certified Athletic Trainer will promote the benefits of student athletics and how athletic training plays a role with participation in athletics, in the community and in the school.
7. Sean Mosbey ATC, CSCS will be paid \$34.00 per hour for a total of 1350 hours for the school year. Total cost for the school year will be \$45,900. Service will be provided Monday thru Friday with the hours of service to be arranged with the Athletic Director.
8. The Certified Athletic Trainer will also receive an additional fee of \$175.00 per Football Game played on Saturday or at 7PM. This is to be paid at the conclusion of the season. There will be no more than 20 games for a maximum of \$3,500.00. Total cost to the high school is \$49,400.
9. The Certified Athletic Trainer will be covered with their own malpractice and liability insurance.
10. Sean Mosbey, ATC, CSCS will obtain fingerprint clearance and TB testing for certified athletic trainer(s).
11. Sean Mosbey, ATC, CSCS shall indemnify, hold harmless and defend the SLUSD and its trustees, officers, employees and agents from and against all liability, loss, expense, including reasonable attorney's fees, or claims for injury or damages arising out of the performance of this Agreement but only in proportion to and to the extent such liability, loss, expense, attorney's fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of CCRTL and/or its employees or agents in their performance of this Memorandum of Understanding.
12. The SLUSD shall indemnify, hold harmless and defend Sean Mosbey ATC, CSCS and its trustees, officers, employees and agents from and against all liability, loss, expense, including reasonable attorney's fees, or claims for injury or damages arising out of the performance of this Agreement but only in proportion to and to the extent such liability, loss, expense, attorney's fees, or claims for injury or damages are caused by or result from the negligent or intentional acts or omissions of Sean Mosbey, ATC, CSCS and/or its employees or agents in their performance of this Memorandum of Understanding.
